Summary: FAPMI Overview

Presentation: The Federation of the Associations for the Prevention of Child Mistreatment (FAPMI) is a non-profit organization, that incorporates people and associations orientated towards the defense of the rights of minors to join their efforts in promoting the good treatment of children and adolescents. Our Federation, free of any political and religious connections, has the common link of all of our efforts to improve the attention for the minors throughout childhood and adolescence. The Federation is included in the National Register of Associations of the Interior Department with the date of the 22 of October of 1990, with registration information: Group: 1; Section: 2; National Number: 1.206 and with the Fiscal Identification Code G 79986493. Also, activities are developed under the Law 1/2002, of 22 of March, regulator of the Right of Association, and complementary regulations.

Currently, the Federation is made up of more than 100 professionals. The Federation is an institutional collaborator of the Spanish Government and the Regional Administrations and other national organizations. FAPMI participates in the National Childhood Observatory of the Health and Social Policy Department, the Work Groups about Child Mistreatment and Child Sexual Exploitation of the Observatory, and participates in the elaboration of the National Strategic Plan of Childhood and Adolescence and the National Plan for Action taken Against Sexual Exploitation of Children. At the same time, the Federation has representation in the Directive Board of the Platform of Childhood Organizations of Spain, and participates in the National Commission of Help to Victims of Delinquent Violence and Against Sexual Indemnity (Justice Department).

Background: FAPMI was founded on June 6th, 1990 as a National Federation of associations related with the defense of children. The promoter associations were the ones represented in Catalonia, Madrid and Basque Country. The associations that shape the Federation have been progressively created in each Region of Spain since the end of the decade of the 1980s of the past century, due to the need detected by professionals in different fields in order to get to know the reality of the mistreatment of the child-youth population, and promote its study and prevention, as well as more efficient intervention strategies. It was considered then, like today, a very serious problem which is required to advance with institutional and civic answers. We want to stand out the organization of the VI European Convention on Child Mistreatment, held in 1997 in Barcelona, together with the International Society for Prevention of Child Abuse and Neglect (IPSCAN).

Vision: To obtain, together with all of the social workers, entities, organizations and institutions linked directly and indirectly with children, the eradication of all forms of mistreatment towards children and adolescents, achieving the establishment of positive relationships styles, based on good treatment and respect of child and adolescent rights.

Mission: Beginning with the Convention of Child Rights of the United Nations, we work to promote good treatment to children and the prevention, detection, accusation and intervention of any situation of mistreatment that affects children, adolescents and their families.

Organizational structure: The Board consists of 9 members, one from each Region where the Federation has representation. The members remain in the post for 4 years. In addition, there are 7 substitutive Councilors. The

the past century, due to the need detected by professionals in different fields in order to get to know the reality of the mistreatment of the child-youth population, and promote its study and prevention, as well as more efficient intervention strategies. It was considered then, like today, a very serious problem which is required to advance with institutional and civic answers.

Currently FAPMI is present in some regions of Spain, with the objective of including the entire Nation and convert itself in the first Non-Governmental Organization dedicated to the fight against Child Mistreatment with presence in the entire Spanish territory. Below we describe some of the signicant collaborations carried out by the Federation or its member Associations, together with the numerous collaborations with local and regional entities that form part of the habitual task of the Associations:

- The Federation and its institutional members have created more than 170 national and regional programs and projects.
- FAPMI forms part of the Spanish Group of Work against Sexual Child Tourism, together with the General Secretary of Tourism and other organizations.
- Since its beginning until today, it has organized 10 State Conventions of Child Mistreatment.
- Organization of the VI European Convention on Child Mistreatment, held in 1997 in Barcelona, together with the International Society for Prevention of Child Abuse and Neglect (IPSCAN).
- Development of diverse programs against Sexual Commercial Exploitation of Children by the Catalonian Assocation for Mistreated Children (ACIM) in collaboration with Jurists without Borders, UNICEF, Save the Children and Anesvad, in the framework of the Consortium ECPAT Spain.
- Participation in the design, follow-up and evaluation of the National Strategic Plan of Children and Adolescents and the National Plan against the Sexual Exploitation of Children, in its different editions.
