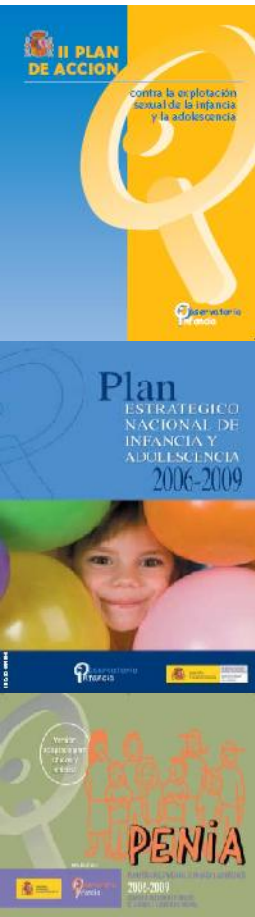

PUBLICATIONS

The presence of minors in the judicial field is becoming more frequent. Nonetheless, both the system and its principal actors such as Judges, Lawyers and District Attorneys lack the strategies and tools necessary to avoid the Institutional Mistreatment that is produced within the legal process, where children that are not capable of understanding the nature of it, nor the functions that are carried out by those who lead, take participation.

Together with the **Convention of Child Rights**, the **European Council** gathers this need and establishes the development of Sociable Justice as the priority aim for the Member States. Under this title, diverse initiatives directed to bringing Justice to minors, avoiding the mentioned Institutional Mistreatment and permitting the safeguard of their rights and integrity are received throughout the process.

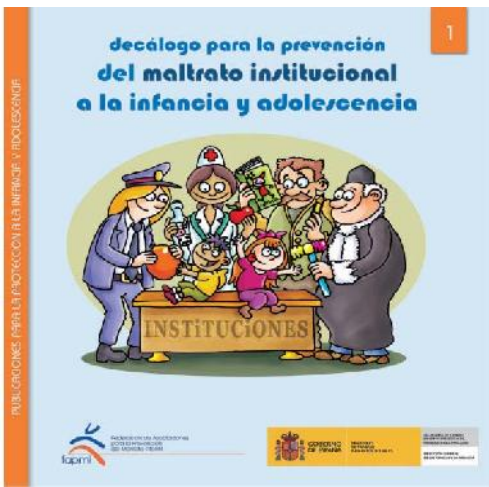
In Spain some precedents that have tried to diminish these consequences exist, but none of such a wide and open spectrum like the one being proposed.

In 2008, the **Federation of Associations for the Prevention of Child Mistreatment** published the **Decalogue for the Prevention of Institutional Mistreatment of Children and Adolescents** with the financing of the **Department of Education, Social Policy and Sports**. This document already stated the need for the Justice field, along with others, to adopt a series of criteria and good practices within their relationship with minors.

The Project “**Justice to Children**” tries to develop this frame of action, directing its activities to the adults that participate in the defense of Minor Rights (Judges, District Attorneys and Lawyers) as well as to the minors in a direct way, that way gathering the interest of the current Administration in the approach to this matter.

Finally, the Project presents the singularity of trying to do it through a participative work plan, which is referred to as an approximation of Justice to minors, in which the children explain to their peers what each one of the figures that they can encounter, and the processes in which they will find themselves immersed, mean.

Through the dynamics of participation of Minors, we attend to the other **recommendations of the Convention of Child Rights**, precisely centered on the promotion of the participation of Minors in the instances that affect them, as a form of contributing to their rights and development as responsible citizens.



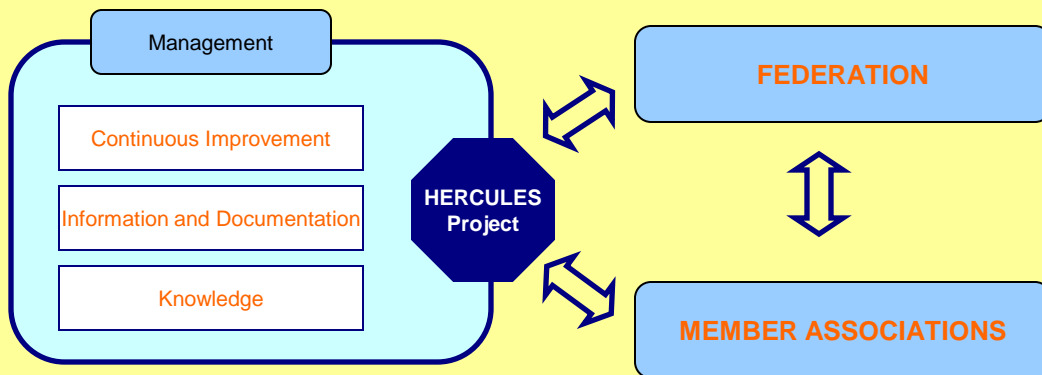

Declaration Request OF PUBLIC USE

- One of the strategic objectives that we have been working on since 2008 is the Request of the Declaration of Public Use of the Federation.
- Some of the Member Associations have already achieved this certification, for which is understood that the same structure that gives them support must also be its candidate. Likewise, we consider that its another step in the process of Continuous Improvement, in which we are immersed, and that results complementary to other working initiatives such as the **HERCULES Project**, currently in the design phase and that will be activated in 2009.
- Along this line and as a requisite to achieve the Declaration of Public Use, throughout 2008 we have audited the years 2005 and 2006, leaving the auditing of 2007 and 2008 to be done in 2009.



The **HERCULES Project** is defined as an Integrated System of Management of Continuous Improvement, Information and Knowledge, designed to give answers to the organization needs of the Federation and its Member Associations, given that all the documents, formats and protocols are distributed to them periodically.

The Management System is available, and since its users are the Federation and its Associations, it permits the incorporation of their contributions, with the intention of facilitating its performance areas.

Furthermore, the **HERCULES Project** incorporates the digital version of the **Federal Documentation Center (CEFIR)**, which is distributed to the Associations through the updated versions of the **HERCULES Project**.

THE MASS MEDIA MUST REGULATE ITSELF AND AVOID THAT GIRLS OF 14 SPEAKS WITH HER FACE UNCOVERED.

Consuelo Madriagal: "the sentence of the murderer of Marta del Castillo could change if her body isn't found"

Enrique Rodriguez: "For every 500 webpages with pedophile contents that we close, another 1,500 open."

Enrique Garcia: "There are always brainless people that take example of what they see in the Mass Media"

MADRID, 18th of February: Organized by the **News Agency Fax Press** and with the sponsorship of the **Maia Foundation** and of the **Baby Nuk Institution; the discussion: AGAINST CHILD VIOLENCE** has joined together companies, NGO unions and professionals related with the world of the minor.

Consuelo Madriagal, fiscal coordinator of Minors, **Mr. Enrique Rodriguez**, Head Inspector – Head of the operative section of protection to minors of the National Police and **Mr. Enrique García fernandez-Abascal**, spokesperson of the Baby Nuk Institution and professor of the Faculty of Basic Psychology of the UNED, have coincided in the need that the mass media must self-regulate and avoid that 14 year old girls speak with an uncovered face, the case of the girlfriend of the suspected murderer of Marta del Castillo.

Madriagal has been strict and in spite of that the social alarm went off again due to the kidnapping and crime of the young Sevillian woman, in which a minor ages 15 has been accused, the District Attorney of Minors Office is not partial to making the Law of penal responsibility more severe for minors and affirmed that increasing the sentence of minors will only serve to "criminalize" the youth: *"When a minor commits a crime, normally it is due to a failure of educative, family and social powers. Protection of the State and of the Administrations also fails in these cases"*. However, the District Attorney, who also does not consider it advisable to reduce the age of impunity of minors under 14, established by the current law, is partial to "intervene" in earlier ages when children who commit an offense are 13, or even 12 years old, but in an educational and pedagogical form, never in a criminalizing way.



In this respect, another speaker of the discussion, the chief-inspector of the operative section of protection of minors of the National Body of Police, Enrique Rodríguez, informed that *there are more adults, including the parents, that send their young children to commit a crime due to the "advantages" that they possess in the criminal field.*

In regards to the death of the young Marta del Castillo, both experts highlighted the dangerousness of the social networks of Internet. The murder of the 17 year old Sevillian by her exboyfriend, Miguel Carcaño," could have been caused by the pictures "hung" in "Tuenti", according to the first hypothesis. The District Attorney of Minors emphasized that these "online spaces fulfill a policy of minimum preventions" which should be raised, and stressed the importance that the parents know and understand the functioning of these networks.

The professor of the Faculty of Basic Psychology of the UNED and spokesperson of the Baby Nuk Institute, Enrique García , also wanted to report during breakfast, the informative treatment offered concerning the death of the young woman, especially because the current girlfriend of the alleged murderer of Marta, a 14 year old minor, held various interviews with different television programs. *"There is a need for more self-regulation in the mass media, because there are always brainless people that take example. After she participated in the first program, other offers came pouring in. ", he criticized.*

On the other hand, the District Attorney of Minors, wanted to highlight the importance of finding the young Sevillian's corpse, where a search in the Guadalquivir River has already been in action for four days without success. *"The body is the principal evidence of the cause of death and in order to confirm what are now just theories",* informed Madrigal, who considers that in the case that they don't find the corpse, the investigation would be much more difficult and emphasized that even *the sentence that would fall on Miguel Carcaño could vary without knowing from the autopsy if the alleged killer threw Marta in the river still alive, in which case he would be charged for murder, and not a homicide.*

CHILD PORNOGRAPHY

In Spain the number of arrests for having or distributing child pornography ascends to 1,200 people. Actually, the Brigade of Technical Investigation receives between 30,000 and 40,000 reports associated with this crime a year in its email.

Rodríguez emphasized the peak that child pornography has experienced in the last years due to the internet. *"The pedophiles can easily communicate in a semi-anonymous way", declared the inspector, that informed that through his experience, the pedophile normally begins looking at general pornography and later looks for something "rare and different" and therefore starts to look at photos of children, until the pedophile converts into a pederast".*

Despite that the debate has extended into France and that recently extended into Italy, and our country (Spain), the spokesperson of the Baby Nuk Institute doesn't believe that the chemical castration is the panacea to avoid sexual crimes. "*The castration can prevent part of a sexual act, but not the impulse. It has even been demonstrated that the people that have practiced it, have committed crimes with objects*", emphasized this expert in psychology during the discussion.

Throughout 2008, a total of 400 people involved in the diffusion of the contents of child pornography were arrested. Nevertheless, during the meeting it was stated that the majority of them managed to get away from going to jail. "*For every 500 webpages with this type of contents that we close down, another 1,500 open*", announced Rodríguez, estimating that more than 400 million Internet zones with sexual material of minors exist.

Nonetheless, although the subject of sexual abuse and child pornography has recently caused great social alarm thanks to recent arrests, the violence and aggression towards children was one of the other issues that lead the discussion. According to the data which was gathered during the meeting, between 10 and 20 percent of the adult population has suffered some type of mistreatment during their childhood, with the percentage of assaulted boys (53 %) slightly higher than that of the girls (53 %). In addition, 80 percent of the cases of child mistreatment occur in the family or school environment of the minor.

Children are not leftwing or rightwing, therefore we all have to be completely united in order to protect the minors", affirmed the ex-Defender of Minors of the Community of Madrid, Pedro Núñez Morgades, also present in the discussion, and who was in favor of bettering family conciliation.

The head of social pediatrics of the Child Jesus Hospital, Jesús García , plead to abandon the discussions concerning mistreatment and to begin the promotion of "good treatment" towards children, and therefore be able to stop the multitude of cases in which violence against minors is tolerated and gave daily examples that were applauded: the figure of the "*substitute parent*" referring to the grandfather or grandmother that fills the parent figure, the "*syndrome of the cash dispense*" where the parents are converted into credit cards or the "*adolescent with social phobia*" that reduces his or her relation with the family in his or her bedroom, an impenetrable sanctuary that only lacks the small window in order to pass food. Without forgetting the fact that many parents only see their children in a horizontal position: when they leave for work, they are sleeping and when they get home, they are sleeping again... to end by saying that today, in Spain there is no real information of child mistreatment.
