

HISTORY AND EVOLUTION OF THE FEDERATION.

Federation of the Associations for the Prevention of Child Mistreatment (FAPMI) was founded in Madrid on June 6th, 1990 as a National Federation of associations related with the defense of children. The promoter associations were the ones represented in Catalonia, Madrid and Basque Country.

The associations that shape the Federation have been progressively created in each Region of Spain since the end of the decade of the 1980s of the past century, due to the need detected by professionals in different fields in order to get to know the reality of the mistreatment of the child-youth population, and promote its study and prevention, as well as more efficient intervention strategies. It was considered then, like today, a very serious problem which is required to advance with institutional and civic answers.

Currently FAPMI is present in varios regions of Spain, with the objective of including the entire Nation and convert itself in the first Non-Governmental Organization dedicated to the fight against Child Mistreatment with presence in the entire Spanish territory.





MISSION, VISION
AND VALUES





Where are we going?

"The children of today are the adults of tomorrow".

Our efforts are directed to create an environment free of any type of mistreatment towards children and adolescents and to the development of a style of interaction based on good treatment. In order to achieve this goal, we need to represent all the people and organizations that pursue this same objective. We need to increase our institutional presence in all of the nation, make our message, mission and vision reach the Spanish population and to convert ourserlves in an official spokesperson with the Administrations and significant social partners. We need to develop broad spectrum projects and actions that sensitize anyone that is able to do something in order to avoid situations of mistreatment, discrimination, risk and abandonment of the people that are minors, and at the same time recognize and respect their rights.



Vision:

To obtain, together with all of the social workers, entities, organizations and institutions linked directly and indirectly with children, the eradication of all forms of mistreatment towards children and adolescents, achieving the establishment of positive relationships styles, based on good treatment and respect of child and adolescent rights.

Mission:

Beginning with the Convention of Child Rights of the United Nations, we work to promote good treatment to children and the prevention, detection, accusation and intervention of any situation of mistreatment that affects children, adolescents and their families.



Values:

The Federation of Associations for the Prevention of Child Mistreatment and its Member Associations accept the values named in the Declaration of Commitment for the Quality in the Third Sector of Social Action proposed by the Platform of Non-Governmental Organizations of Social Action as its own. This commitment assumes the development of a culture of fundamental Quality in determined values that the Federation incorporates to their management system.

Values oriented towards people:

- Respect for human dignity and defense of human rights.
- Solidarity between those that make up our organization, its member organizations and between those that have accepted our services, and their recognition to participate in the decision making that directly affects them.



Values centered in the Organization:

- The management of the organization measured according to the needs and expectations of its recipients.
- Participation by all people, whether volunteers, professionals or fundamental value users to achieve stronger motivation and efficiency in the services.
- The promotion of joint responsability and the commitment of all people implimented in the organization, facilitating descentralization processes in decision making.
- The value of professionalism in human resource policies and the value of good work, in function with more advanced technical and scientific criteria, as well as strict professional ethics.
- Effective management of the totality of the mission of the organization in its everyday task, avoiding the loss of the sense of the mission of our organization.



Values oriented to Society:

- The transparency in the management of resources and the demonstration of its efficiency.
- Social responsibility and permanent commitment to this responsibility.

Other necessary values:

- Complementarity: Add our efforts to those of other workers, entities and organizations with similar objectives and fields of action. Center our efforts in the development of innovation in the protection, defense and attention of children and the prevention of children in risky situations.
- **Synergy**: Create a context of resource, project, strategy and line of action exchange with other social workers in function to increase the protection of children.
- **Transparency**: Manage our resources and projects in a reliable way and when possible, follow-up and evaluate activities, their objectives and lines of development.
- Efficiency: Achieve our objectives using the least amount of resources possible, obtaining the the best results with the ideal management of human resources and materials.



The Federation of Assocations for the Prevention of Child Mistreatment (FAPMI) has as principal target groups of their actions, child and adolescent victims of any type of mistreatment, either within the family, intrafamiliar, extrafamiliar or institutional. Also the families, whether mistreated or not, are object to its actions.

Objectives of The Federation of Assocations for the Prevention of Child Mistreatment (FAPMI) include:

- a) Coordinate and promote the activities of the Affiliated Associations dedicated to the prevention of child mistreatment, attention to children and adolescents at risk and/or abandonment and to the improvement of the quality of life of children.
- b) Maintain relationships of collaboration with all of the public and private institutions, organizations and entities, both national and international that have similar or complementary aims to those of the Federation, accepting the stated in Article 2.6. of the Law 1/2002, of the 22 of march, regulator of the Right of Association.
- c) Sensitize, inform and advise society, collective groups and individuals, and professionals about the problem of mistreatment of children in all of its forms.
- d) Sensitize, inform and advise society, collective groups and individuals and the professionals related to the field of child protection about the need to promote good treatment to children and adolescents by all social workers.

AIM AND TARGET GROUPS

- e) Promote and coordinate studies about incidents, detection, prevention and attention to mistreated children and adolescents, sexual exploitation of children, children and adolescents at risk and/or abandoned, disappeared minors, and any other questions relevant to children and adolescents.
- f) Colaborate in the creation of national and international information systems in respect to the objective of finding out the extent of the pheonemon and analyzing the establishment of the measurements that reduce or relieve situations of risk or defenselessness of people that are minors.
- g) Promote plans of formation, design lines of intervention, confront experiences and encouragement of good practices relative to the attention given to children and adolescents by all members of the Federation of the Associations for the Prevention of Child Mistreatment (FAPMI) and third parties.
- h) **Form and advise** about child mistreatment, mistreatment between equals and the attention given to children and adolescents in a situation of risk and/or abandonment to professionals and institutions of all types.
- i) Create and maintain a documentary fund about child mistreatment, attention given to children and adolescents in a situation of risk and/or abandonment in all of its forms.
- j) Promote and develop programs of defense of children and adolescents, on both a national and international level.



AIM AND TARGET GROUPS (cont.)

- k) Promote the development of any activity
- directed to the prevention, detection, and treatment of child mistreatment, attention to children and adolescents at risk and/or abandonmentand to the context in which it occurs.
- I) Promote the development of programs and activities that are used in a family environment or that have the family as their central figure.
- m) Promote acts of awareness and encouragement of association of family character, favoring the integration asociativa of the families for the defense of their common interests and/or the dissemination and promotion of the work that develops family entities.
- n) Develop acts of awareness, promotion of good practices and innovative experiences to help families through the realization of diffusion activities, forums and reports designated to promote awareness, knowledge, debate and formation of professionals and technicians in relation with the families, especially with those that find themselves at risk and/or have social difficultly and with attention to women who are object to domestic violence and that are in care of children that are minors of age, with those being the main priority.
- ñ) Develop programs for the improvement of quality of life for children and adolescents in situations that require alternative measures of internment, encouragement of foster families for minros, adoption of children with special needs protected by Administration.


- o) Promote the application of the Convention of Child Rights
 of the United Nations, sensitize the institutions, entities,
 organizations, and the society in a combined respect.
- p) **Encourage establishment of child association**, educating in the participation and child resposibility, especially in populations that are at risk and/or have social difficulty.
- q) Practice legal actions and Laws relevant to the defense, protection and attention to Children and Adolescents, as well as situations of mistreatment of any type to these populations.
- r) Direct and promote legislative development proposals and models of intervention that have application and validity in the national field relative to the described objectives in the present Statutes.
- s) Promote volunteer work, social awareness, participation and social mobilization in all of the activities developed by the Federation or by its member associations.
- t) Formation and qualification of the volunteers for their incorporation in the activities in function with their goals, those of the Federation and of the Associations that make it up.









COMMITMENT OF QUALITY AND CONTINUOUS IMPROVEMENT






OUR ETHIC COMMITMENT, GOOD PRACTICES AND THE TRANSPARENCY OF MANAGEMENT

In consequence with our clear orientation to the Continuous Improvement of our activities and processes, we must observe the recommendations that are being given by different entities and institutions in order to optimize, from a wider perspective, the functioning and services of the NGOs and, in our case, in a more specific way, the attention to children and their environment.

Because of this, we value the main model guidelines of Quality Management (ISO, EFQM, ONGconCalidad), the recommendations of the Loyalty Federation and of the different institutions, entities and organizations with which we collaborate. Likewise, we take on the Declaration of Commitment of Quality in the Third Sector of Social Work proposed by the Observatory of Quality of Social Work, written by 72 institutions.

These guidelines and recommendations are taken in account when designing our statute and other documentation, as well as when writing the Internal Procedures Manuals.

With the intention of materializing this commitment, the Federation of Associations for the Prevention of Child Mistreatment has developed two basic documents that guide our activities: The Regulations of Internal Regime and the Ethics Code, of Good Practice and Transparency.

Historically, the work of the Federation has been developed in collaboration with the previous Department of Labor and Social Matters (MTAS), which is currently the Department of Education, Social Policy and Sports (MEPSYD). The support, help and subventions received from this institution has permitted us to develop numerous national and autonomous projects and iniciatives.

Among them, we should emphasize on the organization of the successive National Conferences of Child Mistreatment or the Child Mistreatment Awareness Campaigns, which we mark within our project "My Wellbeing is your Responsibility".

Together with these national activities, a large number of actions exist that have developed from an autonomous level through the Affiliated Associations, as can be verified in the Annual Journals of the Associations mentioned.

Today, the help and support of the Department to the projects undertaken by the Federation is continuous, as much as in financing, as in what is referred to as institutional support.



INSTITUTIONS AND ORGANIZATIONS IN WHICH WE PARTICIPATE



The Observeratory, devoted to the Department of Education, Social Policy and Sports, is a platform to get to know the situation of the youngest children from different perspectives. The distinct administrations and associations of children in favor of wellbeing and in the quality of life of the child and adolescent population collaborate together. Their work develops through specific Work Groups, in which the Federation actively participates.



The Platform of Organizations of children was legally constituted on November, 19th 1997 with the goal of uniting the efforts of the entities whose objectives were the protection and Promotion of the Rights of Children according to the Convention approved by the General Assembly of the United Nations on November, 20th 1989 with a national institution status.



ECPAT International is a network of organizations and of individuals that work together to eliminate child prostitution, child pornography and the sexual traffic of children. ECPAT tries to motivate the world community to ensure that all children in all countries of the world enjoy their fundamental rights and are protected against all forms of sexual commercial exploitation.

ECPAT possesses the status of a consultancy organization before the Economic and Social Council of the United Nations (ECOSOC).





MINISTERIO DE JUSTICIA

INSTITUTIONS AND ORGANIZATIONS IN WHICH WE PARTICIPATE

The Federation participates in the National Commission of Support and Assistance to the Victims of Violent Crimes and crimes against Sexual Liberty of the Department of Justice.

It is a fundamental piece in the Spanish system of protection of crime victims.

Created by the article 11 of the Law 35/1995, of the 11th of December, giving Support and

Assistance to the Victims of Violent Crimes and crimes against Sexual Liberty, it is competent to solve the procedures of contestation of the resolutions in matters of the support contemplated by this law.

Furthermore, the National Commission is also competent to resolve the procedures of contestation of the resolutions of the Interior Department in matters of compensation to the victims of terrorist crimes, in agreement with the Artifcle 96 of the Law 13/1996, of the 30th of December, of Fiscal and Administrative Measures and of Social Order.

The National Commission is incorporated in the General State Administration through the Department of Justice and practices its functions with full autonomy and without subjection to hierarchial instructions. In agreement with its law of creation, it is presided by a Magistrate of the Supreme Courts, proposed by the General Council of Judicial Power.

OTHER SIGNIFICANT COLLABORATORS

The Federation and its institutional members have created more than 150 national and autonomous programs and projects.

II and III National Campaign of Prevention of Child Mistreatment has been designated to be carried out.

FAPMI forms part of the **Spanish Group of Work against Sexual Child Tourism**, together with the **General Secretary of Tourism** and other organizations.

Since its beginning until today, it has organized 9 State Conventions of Child Mistreatment.

Participation in the elaboration of the Report about the application of Child Rights in Spain for the United Nations, in 1994. FAPMI is presently coordinator of the Area of Basic Health and Child Wellness of the Complementary Report of the III and IV Report about the application of the Convention of Child Rights in Spain.

Between 1996 and 1997 it developed the Program about quality standards of good practice in the residential attention of children and adolescents, subventioned by the Department of Work and Social Matters, given place in the edition of **Manual of Good Practice for the Residential Attention to Children and Adolescents**.

Organization of the VI European Convention on Child Mistreatment, held in 1997 in Barcelona, together with the International Society for Prevention of Child Abuse and Neglect (IPSCAN) and the Catalonian Assocation for the Mistreated Children (ACIM).

Development of diverse programs against Sexual Commercial Exploitation of Children by the Catalonian Assocation for Mistreated Children (ACIM) in collaboration with **Jurists without Borders**, **UNICEF**, **Save the Children** and **Anesvad**, in the framework of the **Consortium ECPAT Spain**.

Participation in the design, follow-up and evaluation of the **National Strategic Plan of Children and Adolescents** and the **National Plan against the Sexual Exploitation of Children**, in its different editions.

Colaboration in the campaign "Educate, Don't Hit" promoted by **Save The Children**, **UNICEF**, **CONCAPA** and **CEAPA**, of awareness against physical punishment in families.







CEFIR

In our society changes are produced quickly and the advances in research provide data that permits more productive and effective interventions, which is why it is essential to have constant daily knowledge updates.

In updating, one of the most developed, accessible and valued resources is written and audiovisual information that is at the disposition of professionals and the general population. With the opening and use of the "Federal Center of Information and Resources" FAPMI wants to cover this need and to set up a source of information and training relevant to the associated people and entities, as well as to all of those interested in this phenomenon of mistreatment to children and adolescence.

Within this line of action, FAPMI established a collaboration agreement with the Center of Documentation of Wellbeing and Child and Adolescent Mistreatment of the Faculty of Psychology at the University of Salamanca, under the direction of Professor Félix López Sánchez, a project developed with the help of the Junta de Castilla and León (Regional Government). With this agreement, FAPMI will take charge of the management of the Documentation Center.

The basic objectives of the Center of Documentation of Wellbeing and Child and Adolescent Mistreatment are summed up in:

JUSTIFICATION


Since 1989, National Conferences of Child Mistreatment have taken place biannually. This iniciative intends to grow in a meeting place of professionals that work in the field of child protection and child mistreatment and of the whole Society.

Since the First National Conference took place in Barcelona, we have created a forum in which not only knowledge about how to identify, prevent and act in regards to this type of problem is exchanged, but also about how the profile of the professional in direct contact with this circumstance should be, his or her duties, fields of action and networks of collaboration.

Within this project, we have been joining professionals and investigators from all fields and contexts together to reflect together and generate new proposals at a level to the direct reality, as well as at a national and autonomous level, contributing to the normative development and development of attention devices of high effectiveness and quality.

ORGANIZED CONFERENCES

The I Conference in **Barcelona** implied the importance of recognition of this problem and the need of dealing with it with answers according to its level of seriousness, by the Administrations. The II Conference in **Vitoria** assumed to carry out the commitment of continuing the work started in Barcelona and the implication of the University in the topic of child mistreatment.





ORGANIZED CONFERENCES

Likewise, the III Conference, celebrated in **Madrid**, brought up the issue of where the Society should direct itself, its efforts and answers in the prevention of and attention to mistreatment. In the IV Conference, which was held in **Seville**, reflection on quality and the good practice in the social protection of children was introducted. The V Conference, celebrated in **Valencia**, dealt with the problem of mistreatment in regards to the human, social and economic cost and the value of good treatment.

The VI Conference, held in **Murcia**, exposed the need for Spain to arrange an Integral Plan of Attention to Children and the consideration of treatment that is offered to the children by the institutions. The VII Conference was celebrated in **Madrid** and it was centered on the need to foster the role of the Observatory of Children, as well as the opportunity for each Region of Spain to promote the policies of children. The VIII Conference, celebrated in **Santander**, had the intention of promoting Good Treatment of Children, and designing the concept of good treatment as a new form of defining the relationship with children.

Finally, the IX Conference was held in **Valladolid** during the month of November in 2008. Under the slogan, "Working in a Network. Keys to Advancing", the need to promote a network model from an ecological and systematic perspective was exposed, for the understanding of the phenomenon of mistreatment by all the actors and social institutions, as well as for its approach by all people and structures related with children at risk.

The next Biannual Conference will take place in Sevilla durante the year 2010.
